

Last September, C2R received a large volume of life safety tips – the result of threats being reposted on social media.

Reposting those threats can hinder law enforcement from determining who made the original post.
Reposting can also lead to serious legal and disciplinary consequences.

Courage2Report now offers free posters to remind everyone: REPORT, DON'T REPOST. This will help to prevent spreading fear, misinformation, and unnecessary panic.



What is Discord?

Discord is a popular free app that allows users to create anonymous accounts. Users can create and join groups, share videos/images, have private voice/video calls, exchange private encrypted direct messages, and have group video chats. "The app is a 'safe haven' for plotting mass violence because it provides an unmoderated service with open chatrooms, closed groups, and private messages for anonymous users." (David Riedman, 2024) It is mostly used for gaming or talking to friends. Think of it as having a community center with different rooms for different activities like a book club, a gaming room, and a baking club or art club.



Here are a few points that school staff should consider:

- Discord chat groups can be private and are unlikely to be internally monitored by the company. If your school district has a threat assessment team it's unlikely that they will be able to see the content in these private groups.
- Direct messages on Discord are encrypted. Even with a warrant, school officials and law enforcement are unlikely to be able to access these messages.
- Students are more likely than adults to see threatening posts made by their peers. If a student reports seeing threating comments or information about a planned school shooting on Discord (or any other online platform), this threat should be taken seriously.
- If you see threatening messages, report them to law enforcement or Courage2Report and continue to follow-up until you have confirmation that the threat has been investigated.
- If a student is engaging with or sharing white nationalist, anti-government, or far-right propaganda, this should be a red flag for gun violence. There is a wide range of threat actors, such as terrorist groups, violent extremist organizations, and violent hate groups that recruit on Discord.
- Join Discord and routinely search for your school's name, school mascot, or nicknames associated with your school or community.

Just because a student is seen on Discord should not be cause for alarm, they are more than likely just chatting with friends. However, in the event there is someone posting about a planned violence attack or discussing previous attacks it would be beneficial to develop a school community where the students frequently using discord for chatting with friends or gaming feel safe in coming forward if they see something suspicious or alarming in a private group or chat. Trusting and engaging with students to recognize the threats that kids are seeing can prevent the next school shooting.





TOP 10 TIPS2PROTECT

for Parents and Trusted Adults



Parents and trusted adults: Online safety starts with knowing what to do — and doing it every day. These tips are designed to help kids and teens navigate the digital world safely and protect them from online exploitation and abuse. Start conversations, set boundaries and take action to protect kids and teens online.

- Start an open, two-way conversation with your child.
- 7 Create a contract with your child regarding online behavior.
- Password-protect or control access to your child's app store and gaming downloads.
- 8 Know your child's friend lists. Remove strangers.
- 3 Set time and area limits for use of devices and set device check-in times.
- Warn your child that they should never leave a game to chat with someone they don't know on a different platform.
- Set all apps, games, and devices to private.
- Turn off location data services on social media and nonessential apps.
- Talk about data permanency. Online data can last a lifetime.
- Do not delete messages, images or videos from predators and do not forward any sexually explicit images or videos. Save usernames, screenshots and images or videos as evidence for law enforcement to collect directly from the device.

LOS 10 MEJORES CONSEJOS DE PREVENCIÓN EN LÍNEA



- 1. Inicie una conversación abierta y bidireccional con su hijo.
- Proteja con contraseña o controle el acceso a la tienda de aplicaciones y a las descargas de juegos de su hijo(a).
- 3. Establezca límites de tiempo y área para el uso de dispositivos y verifique las actividades en línea frecuentemente de cada dispositivo.
- 4. Configure todas las aplicaciones, juegos y dispositivos como privados.
- Desactive los servicios de datos de ubicación en las redes sociales y las aplicaciones no esenciales.
- Hable de la permanencia de los datos. Los datos en línea pueden durar toda la vida.
- 7. Cree un contrato con su hijo con respecto al comportamiento en línea.
- 8. Revisé la lista de contactos de su hijo. Elimine a los extraños.
- Advierta a su hijo que nunca debe salir de un juego para chatear con alguien que no conoce en una plataforma diferente.
- 10. No borre mensajes, imágenes o videos de depredadores y no reenvíes imágenes o videos sexualmente explícitos. Guarde nombres de usuario, capturas de pantalla e imágenes o videos como evidencia para que las fuerzas del orden la recopilen directamente desde el dispositivo.



Handle With Care



In September, Courage2Report received and delivered **56** handle with care notifications to schools and law enforcement across the state.

When schools receive these notifications, they should share them with the child's teacher or other staff on a "need to know basis" so they may observe the child's behavior and be ready to provide trauma sensitive support if needed. This will help the student feel safe and be more receptive to learning.

Attendance is open to school staff, law enforcement, and mental wellness professionals who work with youth. Advance RSVP is required.


