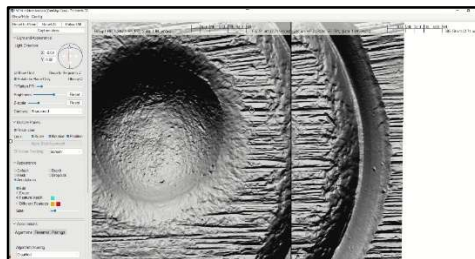

Virtual Comparison Microscopy: The Future of Firearms Examination

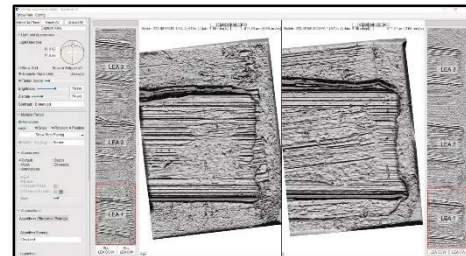
The comparison of fired ammunition components to firearms is a common laboratory request. For nearly a century, firearm examiners have used the comparison microscope to examine and compare the microscopic marks imparted to fired bullets and cartridge cases by a firearm. While the comparison microscope has evolved to include better optics, higher magnifications, and digital cameras, the basic function has remained the same. However, new technology has been under development that is now being adopted by forensic laboratories to aid in the comparisons of fired ammunition components: Virtual Comparison Microscopy (VCM). VCM systems use a scanner to capture high resolution 3D images of an item's surface. The system's computer software then generates a virtual 3D representation of the scanned surface, which includes surface contour information.



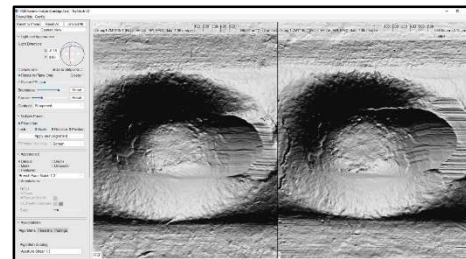
Images can then be examined and compared using the system's computer software, allowing an examiner to adjust an item's orientation and the virtual lighting upon the items as if they were being viewed on a traditional comparison microscope.

VCM can assist examiners by allowing faster and easier adjustment of lighting and item orientation during comparisons and enhanced visualization of microscopic detail on poorly marked items. These systems can also aid in the verification process of comparison results between labs and in examiner training.



In January 2026, the MSHP Crime Lab Division purchased a Cadre Forensics TopMatch-3D VCM system. The system includes both the company's high-capacity desktop and Versa scanners, and was installed at the MSHP Springfield Crime Lab. It is currently undergoing validation for the comparison of fired cartridge cases, prior to casework implementation. A second VCM system will be installed at the Jefferson City Lab in the future. While VCM will not replace the comparison microscope, it will provide examiners with another valuable tool to use during comparison examinations.

Ask the Crime Lab: Firearms

Q: What are the capabilities of the Firearms and Toolmarks section?

A: We examine firearms for identification, test for function (and malfunction), and modification. We examine the marks left on fired cartridge cases and bullets from crime scenes to determine which firearm fired that item. We can also restore serial numbers on firearms, cars, motorcycles, trailers, etc.

Q: Does the Firearms and Toolmarks section submit cartridge cases to NIBIN?

A: The MSHP Crime Lab does not currently have access to NIBIN. However, we can create standards for submission and get you into contact with various NIBIN sites around the state.

Q: What examinations are no longer performed?

A: We no longer perform distance determination, trigger pull, or suppressor testing. If you need these exams, we can help you find a lab that can assist you.

Q: How do I properly package firearm evidence?

A: Firearms should always be unloaded and packaged in a box. We ask that nothing is placed in the action or barrel of the firearm. Firearms can be secured with zip ties so long as they do not pass near the trigger. Magazines and ammunition can be submitted in the same box as the firearm if they are secured away from the firearm. We prefer the actions of firearms closed. More than once a loose cartridge has made its way into an open chamber.

Firearms found in water should be submitted in the water it was found in as soon as possible. Use a plastic tub and try not to expose it to air. Call us ahead of time so we can be prepared. We prioritize these cases to preserve the evidence.

If you cannot unload a firearm, package it separately in its own container and place a warning on the container. It should be secured but nothing is to be placed inside the trigger guard. Let us know you have a loaded firearm being submitted.
